One of the most common and easiest ways to leave a legacy is through a **charitable bequest** in your will or living trust. You can specify a set amount, a percentage of your estate, or a particular asset to be donated to HCN. Here is suggested language for your attorney to review:

"I give, devise, and bequeath to Homeless Children's Network (Tax ID: 94-3266686), a nonprofit organization located in San Francisco, California, the sum of [\$##,###]; or [##% of my estate]; or [description of specific asset] for the benefit of its general purposes [or specify a program]."

Bequests remain fully in your control during your lifetime and become irrevocable only upon passing.

Easy Planned Gifts

Some legacy gifts require little more than updating a beneficiary designation form. Consider naming HCN as a beneficiary of:

- Retirement accounts (IRA, 401(k), or pension plans)
- Life insurance policies
- Stocks, bonds, or mutual funds
- Savings or checking accounts
- Donor-advised funds

To set up one of these gifts, simply request a **beneficiary designation form** from your financial institution and name Homeless Children's Network as a beneficiary. Keep in mind that beneficiary designations take precedence over instructions in a will or trust.
